

Review of Progressivism's Progress; Development of Rhetorical Veils & Hidden Agendas; Example: Global Warming & Seizure of Private Property

Kirk gives the other side of Glaucon's coin. Socrates's associate predicts that the current generation could not be convinced to believe "the noble lie," but their children could. Kirk insists that if the rising generation knew the difference between the truth and the lie they wouldn't need the Academy.

Both Glaucon (γλαυκόν) and Kirk recognize the malleability of children's souls. Glaucon would capitalize on their soul's *tabula rasa* to sell a lie. Kirk recognizes their inability to search for truth on their own and recommends that honorable people teach them how.

When an entire population has been propagandized into believing the lie then Luciferian intent must be considered as its source. He is a liar and the father of lies. His desire and intent is to "Be like the Most High." Such prodigious ambition requires sophisticated organizational skills to bring the diverse and multicultural peoples of this world into a status quo of love, peace, and harmony. And not just for the generation in which it allegedly would be accomplished but that each succeeding generation will also be amalgamated into this restoration of Eden's pristine perfection.

To do this requires the elimination of establishment and doctrinal viewpoint and cramming it down Orwell's Memory Hole in favor of the new paradigm that fulfills the Progressive's collectivist vision.

The only way that such an undertaking can occur is for selected individuals to be recruited by the Dark Side, instructed in Satanic Academy of Cosmic Didactics, and promoted to positions of influence. Each Progressive we have noted, from Gramsci to Obama, has acquired broad access and receptive audiences for their messages and the specific nature of their intent is clearly presented for analysis for any who have the truth to discern it.

Yet the Long March has accomplished its task of transforming the population from an upwardly-mobile, well-educated, spiritually-astute, and traditionalist-oriented electorate to a mind-numbed, Balkanized mob of narcissists. Self-centered and ignorant and thus unable to effectively function in a free, industrialized society, they become nihilists who will follow any Pied Piper promising them happy release.

The "something" is government money and the "nothing" is their effort to earn it. The means of selling an entire population "the noble lie" is to promise anything but in the process set the stage to seize personal freedoms.

This amounts to a conspiracy, although most of the participants are not aware of it. All modern-day conspiracies hide behind the façade of a publicized ideology.

The modus operandi of Progressive thought is best understood by referencing Karl Marx's definition of ideology:

[A pseudo-philosophical, rhetorical veil that conceals while advancing the economic interests of a class.](#)

I have modified this for application to cultural Marxism:

[A pseudo-philosophical rhetorical veil that conceals while advancing a hidden agenda.](#)

The latter defines the modus operandi of Progressive ideology which functions as a conspiracy made up of operatives in academia, media, jurisprudence, and politics.

All conspiracies have leaders whose objectives are power and control. They need an ideology behind which they can conceal while advancing these objectives. Thus they seek a vulnerable group of people who can be controlled by flattery, compassion, anger, or lust. Easy targets are members of special interest groups who are in the Cosmic System under crusader arrogance.

The conspiracy's leaders feed the lust pattern of the crusaders by assuring them that their special interest is not only valid but is being ignored. Such approbation is the catalyst which unites the crusaders with the conspirators. The crusaders become pawns in a plot to reach some unstated and hidden agenda of the conspirators. What develops are ideologies under the Marxist definition: the crusaders become the mouthpiece of the conspiracy.

To illustrate, the conspirators sell the lie of global warming to whoever is willing to buy it. These become the crusaders. They are organized into special interest groups with a stated public agenda which is really a rhetorical veil: clean the environment polluted by irresponsible industrialists and thoughtless citizens.

The conspirators — academia, media, jurisprudence, and politics — enable the crusaders by authenticating the message and providing outlets to communicate it: the academy teaches the lie, media spread it, the courts uphold it, and the politicians get in line: food for oil, carbon credits, and Dairy Queen light bulbs.

The crusaders are motivated to move the agenda forward by the mantra, "the earth must be saved for posterity." They are led to believe the end desired is so righteous that they are justified in using any means in pursuit of it.

But what is the conspirators' hidden agenda: the Fabian seizure of individual property rights, a process that will begin when carbon credits — which in essence is a tax on breathing — are imposed on everyone. Success grants them the power and control desired:

"Ecology offered liberal-minded people what they had longed for, a safe, rational and above all peaceful way of seeming to re-make society, limiting the growth of capitalism, preserving the natural resources through pollution control, developing a more coherent central state." (James Ridgeway. *The Politics of Ecology*. [New York: E. P. Dutton and Co., 1971]).

Compartmentalization is a procedure used by our military to insure the security of an operation. Those involved are given only enough information to execute their portion of the project, no more; no less.

If one participant were to leak information the sum total of his knowledge would not be enough to jeopardize the success of the entire mission. When all parties fulfill their portion of the project the operation runs smoothly. But only one individual, or a very small group, knows the overall picture.

This person, or group, devises the plan, determines who will execute which portion of it, and then decides who does what and when they will do it. Such a procedure is used by Satan in his incessant, unrelenting, and relentless Long March toward global domination.

Under the tactic of "compartmentalization," Lucifer directs — through demon influence and demon possession — the activities of certain special interest groups toward the fulfillment of his hidden agenda.

The rhetorical veil is any crusade which presents some apparent moral and just cause. Progress is attained by imposing tension which produces conflict, and conflict is the driving force for change.
