

23. On August 9, 2014, a local teenager, intoxicated on marijuana, committed petty larceny, assault and battery of a citizen and a policeman, and resisted arrest resulting in being shot and killed by that policeman
24. The president, U.S. attorney general, and the governor of the State of Missouri immediately declared that the officer should be indicted for murder or manslaughter thus giving carte-blanche permission for rebels to wreak havoc on innocent people, private businesses, and automobiles with impunity.
25. Following the grand jury's decision not to indict the police officer, comments by the president continued to incite the masses by subtly denouncing the findings of the grand jury by justifying violence to people and property in Ferguson and other locales around the country.
26. In the process, he indicted himself regarding his recent "executive order" to allow five-million illegal residents to be naturalized with these remarks:

"First and foremost we are a nation built on the rules of law. And so we need to accept that this decision the grand jury's to make. There are American's who agree with it, and there are American's who are deeply disappointed, even angry. It's an understandable reaction. But I join Michael's parents in asking anyone who protests this decision to do so peacefully. Let me repeat Michael's father's words: 'Hurting others or destroying property is not the answer. No matter what the grand jury decides, I do not want my son's death to be in vain. I want it to lead to incredible change, positive change; change that makes the St. Louis region better for everyone.' Michael Brown's parents have lost more than anyone. We should be honoring their wishes.

"I also appeal to law enforcement officials in Ferguson and the region to show care and restraint in managing peaceful protests that may occur. Understand that our peace officers put their lives on the line for us every single day. They've got a tough job to do to maintain public safety and hold accountable those who break the law. As they do their jobs in the coming days, they need to work with the community, not against the community, to distinguish the handful of people who may use the grand jury's

decision as an excuse for violence, distinguish them from the vast majority who just want their voices heard around legitimate issues in terms of how communities and law enforcement interact.

“Finally, we need to recognize the situation in Ferguson speaks to broader challenges that we still face as a nation. The fact is in too many parts of this country a deep distrust exists between law enforcement and communities of color. Some of this is the result of the legacy of racial discrimination and this is tragic because nobody needs good policing more than poorer communities with higher crime rates. The good news is that we know there are things we can do to help.

“I’ve entrusted Attorney General Holder to work with cities across the country to help build better relations between communities and law enforcement. That means working with law enforcement officials to make sure their ranks are representative of the communities they serve. We know that makes a difference. That means working to train officials so that law enforcement conducts itself in a way that is fair to everybody. It means enlisting the community actively on what should be everybody’s goal and that is to prevent crime.

“There are good people on all sides of this debate, as well as in both Republican and Democrat parties that are interested in lifting up the best practices because we know that there have been communities that have been able to deal with this in an effective way but also who are interested in working with this administration and local and state officials to start tackling much-needed criminal-justice reform. So, those should be the lessons we draw from these tragic events. We need to recognize that this is not just an issue for Ferguson; this is an issue for America.

“We have made enormous progress in race relations in the course of the past several decades. I have witnessed that in my own life and to deny that progress, I think, is to deny America’s capacity for change. But what is also true is that there are still racial problems and communities of color are not just making these problems up. Separating that from this particular decision, there are issues in which the law, too often, feels it is being applied in a discriminatory fashion. I don’t think that is true for the majority of communities or the vast majority of law enforcement officials. But these are real issues We must try to understand this and figure out how to make more progress.”¹

1. There are a number of disconnects expressed by the president in what he said and what actually happened. In doing so, he contributed to or supported the intended disconnection expressed by the rioters who are promoting a hidden agenda.
2. It was Karl Marx who developed a definition for an ideology: A pseudo-philosophical rhetorical veil that conceals but advances the economic interests of a class.
3. In 1990, I developed a spin-off of Marx' idea and developed a definition for Lucifer's strategy to control the world: A pseudo-philosophical rhetorical veil that conceals while advancing a hidden agenda.
4. Philosophy is defined as "the study of the fundamental nature of knowledge, reality, and existence, especially when considered as an academic discipline."²
5. Pseudo means "false" thus Lucifer develops false philosophies which he communicates through demon possession and demon influence. The current rendition of his pseudo-philosophy is "progressive ideology."
6. Progressivism has adopted many of the tactics utilized by the Soviet communist party during the leaderships of Vladimir Lenin, Josef Stalin, Nikita Khrushchev, Leonid Brezhnev, Yuri Andropov, Konstantin Chernenko, and Mikhail Gorbachev.

7. Progressivism is defined as follows:

A broad philosophy based on the idea of progress, which asserts that advancement in science, technology, economic development, and social organization are vital to improve the human condition. Progressivism became highly significant during the Age of Enlightenment in Europe, out of the belief that Europe was demonstrating that societies could progress in civility from barbaric conditions to civilization through strengthening the basis of empirical knowledge as the foundation of society. Figures of the Enlightenment believed that progress had universal application to all societies and that these ideas would spread across the world from Europe.³
8. The concepts which serve to coordinate all the elements of satanic strategy include duplicity and deceit.
9. They provide the confusion necessary to conceal from the benighted Lucifer's hidden agenda. One of the depended upon results is a disconnect from reality.
10. "Disconnection" is defined by *The New Oxford American Dictionary* as "(a person) lacking contact with reality; (of speech, writing, or thought) lacking a logical sequence; incoherent: *a disconnected narrative*."
11. As we read through the president's comments we discover a number of inconsistencies:
 - (1) The president states that we are "a nation built on the rules of law" yet on November 21 he violated the Constitution by unilaterally granting amnesty to five-million illegal aliens.
 - (2) He opined that, "this decision was the grand jury's to make." In fact, it is required by the Constitution:

Amendment V: No person shall be held to answer for a capital, or otherwise infamous crime, unless on a presentment or indictment of a Grand Jury.

- (3) As Ferguson burned, POTUS announced that it – the reaction – was “understandable” while at the same time urged “anyone who protests this decision to do so peacefully.”
- (4) Then he expresses the hidden agenda behind the violent protests: “I want it – Brown’s death – to lead to incredible change.”
- (5) He then indicts law enforcement officials with this comment: “As they do their jobs in the coming days, they need to work with the community, not against the community.”
- (6) Then he fosters the idea of violent reaction by suggesting such may well occur by warning the police that a “handful of people may use the grand jury’s decision as an excuse for violence.”
- (7) This reaction is distinguished from “the vast majority who just want their voices heard around *legitimate issues* in terms of how communities and law enforcement interact.”
- (8) He then insults Officer Wilson and law enforcement in general with the accusation “we need to recognize the situation in Ferguson speaks to broader challenges that that we still face as a nation.”
- (9) This statement is not directed at Brown’s multiple crimes but at Wilson carrying out his duties in apprehending a suspect of committing these crimes.
- (10) Next comes the Race Card but his logic is self-contradicting: “in too many parts of the country a deep distrust exists between law enforcement and communities of color.”
- (11) Then he implies that this “distrust” is the “result of the legacy of racial discrimination” but then implores that more police protection is needed in these “communities of color” because “nobody needs good policing more than poorer communities with higher crime rates.”

- (12) Wilson was in the act of apprehending a man who stole property, assaulted the storekeeper, attacked the officer, and resisted arrest.
- (13) Then comes the coup de grace. POTUS appoints Attorney General Eric Holder, a man who is under investigation himself, "to work with cities across the country to help build better relations between communities and law enforcement."
- (14) He uses the words "community" or "communities" eleven times during his remarks which reflect his time in community organizing crime-ridden Chicago.
- (15) His first act in organizing communities is "to make sure their ranks are representative of the communities they serve."
- (16) This is accomplished by "working to train officials so that law enforcement conducts itself in a way that is fair to everybody," except in this case, not Officer Wilson who was exonerated of any wrongdoing by the grand jury.
- (17) Yet he goes on to state the objective of this effort "on what should be everybody's goal and that is to prevent crime" which is exactly what Office Wilson was trying to accomplish.
- (18) According to testimony by numerous corroborating witnesses, sustaining forensic evidence gathered at the scene, and by three verifying autopsies, the grand jury cleared Officer Wilson of any misconduct.
