

- (19) Yet, the investigation completely disproved the claim of one or more witnesses that Brown held up his hands and said, “Don’t shoot.” This is an affirmed lie yet it has been adopted by the protesters as if it were true.
- (20) This fraudulent quote by Brown has been contorted into a fact in the minds of many and repeated as truth so often that it has been adopted as true.
- (21) Even worse, the executive branch has apparently adopted it as prima facie evidence and again exceeded its authority by assuming communities “are interested in working with this administration and local and state officials to start tackling much-needed criminal-justice reform.”
- (22) Question: What is there to “reform” regarding this case? The grand jury returned a “no true bill”¹ thus affirming that Officer Wilson conducted himself in accordance with standard operating procedure in the course of arresting a suspect.
- (23) POTUS warns that “reform,” based on nothing but civic unrest based on authority arrogance and perpetrated by a lie, have implications for the whole country: “We need to recognize that this is not just an issue for Ferguson; this is an issue for America.”
- (24) “These are real issues. We must try to understand this and figure out how to make more progress.” Implication: the federal government must get involved in exacting this progress so that progressivism can work its assumed magic.
- (25) In so doing, the long arm of POTUS will deploy his ultra-invigorated, anti-constitutional, executive privileges.

¹“Indictment: a formal written accusation, drawn up and submitted under oath to a grand jury by the public prosecuting attorney, charging one or more persons with a crime. The grand jury must determine whether the accusation, if proved, would be sufficient for conviction of the accused, in which case the indictment is indorsed by the foreman as a true bill. Once an indictment is filed, the matter passes to the Court. Indictments also serve to inform an accused of the offense with which he is charged and must be clear enough to enable him to prepare his defense adequately” (Steven H. Gifis, *Dictionary of Legal Terms*, 3d ed. [Hauppauge, NY: Barron’s Educational Series, 1998], 233).

12. The disconnection that has defined POTUS's comments is built on a lie: "Hand's up, don't shoot," thus accusing Office Wilson of murder when in matter of fact Brown uttered no such plea.
13. Yet, the phrase has been adopted as truth giving credence to the lie. Tell a lie long enough and it will become a fact.
14. Having heard from the mouths of high-up, elected, public officials, the unexpressed request has become the only piece of evidence needed to justify the condemnation of Wilson, the pillaging of cities, the burning of businesses, and the antagonism of races.
15. Rather than identifying the real culprit in the matter, a lie is used to invert the truth. The untrue claim is used as a tool to condemn an innocent man in order to carry out a hidden agenda.
16. Lucifer promotes the innocence of a criminal to convict a person without guilt. He's done it before—Jesus in place of Barabbas—and he'll do it again.
17. This lie, "Hand's up, don't shoot," may well be under consideration by the editors of *The Oxford Dictionary of Quotations* for the book's next edition.
18. Since the quote has gained so much traction and used as a lightning rod by agitators, race-baiters, and opportunists, let's see the mechanics of how it has been seized upon by Lucifer's strategists to bring our nation to critical point.

Lucifer's Strategy and Hidden Agenda

1. The tools utilized to coordinate all the elements of Luciferian strategy are duplicity and deceit.
2. **Duplicity:** Contradictory doubleness of thought, speech, or action. The belying of one's true intentions by deceptive words or actions.
Deceit: To cause to accept as true what is false.
3. Duplicity and deceit are ingenious ways of utilizing Lucifer's first trick in the book which is lying.
4. In the garden of Eden, the Lucifer-possessed serpent lied to Ishah when he told her in:
Genesis 3:4 - The serpent said to the woman, "You shall not surely die."
5. The woman had just refused to eat of the tree of the knowledge of human good and evil on the basis of God's mandate in:
Genesis 2:17 - "but from the tree of the knowledge of good and evil you shall not eat, for the day that you eat from it you will surely die."
6. Lucifer's lie was that she would not die. This was a deceitful lie causing Ishah to believe as true that which was false.
7. Ishah was weak on doctrine and therefore did not have strong enough norms and standards to realize that the serpent was challenging the veracity of God's Word.
8. Lucifer counted on her lack of doctrine. He knew that physical death would not immediately follow the decision to consume the forbidden fruit.
9. What the devil failed to remind her was that spiritual death ultimately leads to physical death.
10. Dumbing down the benighted is the objective of imposing a national curriculum. Common Core teaches the lie so that at critical point the masses will believe "Hands up" as truth rather than forensics.

11. In one of His many battles with the Pharisees, our Lord associated these men with Lucifer, teaching the common bond between them to be a propensity toward lying.
12. Jesus distinguishes the Jews' father Abraham, which the Pharisees emphasize as their earthly father, from *Theós* who is the only legitimate heavenly Father.

John 8:43 - Why do you not understand what I am saying? It is because you cannot hear [*dÚnamai* (*dúnamai*): without innate power to understand] My word.

v. 44 - “You are of your father the devil, and you want to do the desires of your father. He was a murderer from the beginning [**Genesis 4:8; 1 John 3:12**], and does not stand in the truth because there is no truth in him. Whenever he speaks a lie, he speaks from his own nature, for he is a liar and the father of lies [**Genesis 3:4–5**].

v. 45 - “But because I speak the truth, you do not believe Me.

v. 46 - “Which one of you convicts Me of sin? If I speak truth why do you not believe Me?

v. 47 - “He who is of God hears the words of God; for this reason you do not hear them, because you are not of God.” (NASB)

13. Deceitful men pose as men of righteousness in order to lead spiritually ignorant believers away from doctrine:

2 Corinthians 11:3 - I am afraid that, as the serpent deceived Eve by his craftiness, your minds will be led astray from the simplicity and purity of devotion to Christ.

v. 4 - For if one comes and preaches another Jesus whom we have not preached, or you receive a different spirit which you have not received, or a different gospel which you have not accepted, you bear this beautifully.

v. 13 - For such men are false apostles, deceitful workers, disguising themselves as apostles of Christ.

2 Corinthians 11:14 - No wonder, for even Satan disguises himself as an angel of light.

v. 15 - Therefore it is not surprising if his servants also disguise themselves as servants of righteousness, whose end will be according to their deeds. (NASB)

14. The art of duplicity and deceit has been perfected in the last decade of the twentieth century.
