

23. Malthus also indicated that the supply of natural resources was limited thus presenting a threat to the survival of future generations. In order to save lives in the future we must prevent lives in the future.
24. He asserted that since natural solutions to this imagined overpopulation problem did not work, then human solutions must be considered. By natural solutions he meant, war, disease, and famine.
25. One of the human solutions was what Malthus called "vice," what we refer to as contraception.
26. Current advances on this theme include abortion of viable fetuses, euthanasia, and sterilization.
27. All these approaches are what inspire the current de-emphasis of national boundaries, presently called the "No Borders" movement which promotes global immigration.
28. No Borders also promotes international control of natural resources. Lucifer coordinates this movement with "climate change" to promote pseudo fear mongering over destruction of the environment.
29. Consequently, Marx, Darwin, and Malthus make up a satanically inspired triumvirate through whom he has developed his strategy and tactics.
30. Their various impacts provide the rhetorical veil which conceals while advancing the hidden Luciferian agenda.
31. Remember the Marxian definition of ideology: "A pseudo-philosophical rhetorical veil that conceals while advancing the economic interests of a class."

32. This human-good driven principle is presently being accomplished in client nation America:

All conspiracies have leaders whose objectives are power and control. They need an ideology behind which they can conceal while advancing these objectives. Thus, they seek a vulnerable group or race of people who can be manipulated by being told they are victims of injustice. Easy recruits are special-interest groups whose members are in the cosmic system functioning under crusader arrogance. Some recruited include minority races, hourly-wage workers, certain religious groups, fraternal organizations, or NFL football players. The conspiracy leaders feed the lust patterns of the crusaders by assuring them that their special interest is not only valid but is being ignored. Such approbation is the catalyst which unites the crusaders with the conspirators. The crusaders become pawns in a plot to reach some unstated and hidden agenda of the conspiracy. What develop are ideologies under the Marxist definition: the crusaders become the mouthpiece of the conspiracy. Their philosophy is really a verbal veil which conceals while at the same time advances the hidden agenda. For example, "Hands up; don't shoot."

The Crusaders' Public Agenda: Clean the environment polluted by irresponsible industrialists and thoughtless citizens. They believe their cause is so righteous that they are justified in using any means in pursuit of their objective including violence, civil disobedience, destruction of private property, and murder.

The Conspirators' Hidden Agenda: The Fabian seizure of individual property rights. Success grants them both the power and control they desire. In each and every case, those who link power lust with some form of arrogance believe their cause to be moral and just.

33. Under the principle of "compartmentalization," Lucifer directs the activities of special interest groups toward the fulfillment of his hidden agenda: economics (Keynesian), education (Common Core), ideology (Progressivism), marriage (verbicide), property rights (Kelo v. New London (04-108 545 U.S. 469 (2005), and many others.
34. The rhetorical veil is any human-good crusade which presents some apparent moral and just cause.  
**Principle:** Tension and conflict are the driving forces that result in change.

35. The rhetorical veil that enables the cause to appear moral and just utilizes three major ideologies:
  - (1) Marxian, which promotes the ideology that all humans are equal.
  - (2) Darwinian, which promotes the ideology that all humanity is advancing toward perfection.
  - (3) Malthusian, which promotes the ideology that future human life is threatened by a lack of basic necessities because of over-population, depletion of natural resources, or by pollution of the ecosystem.
36. These pseudo-philosophical rhetorical veils conceal but advance the hidden agenda of Lucifer's plan which is a globalist dictatorship under his control.
37. The Scripture instructs believers that they are not to be ignorant of rhetorical veils or hidden agenda.

**2 Corinthians 2:11** - So that no advantage would be taken of us by Satan, we are not ignorant of his schemes.
38. The word "schemes" is the noun **νόημα (nóēma)**. It refers to the strategy and tactics of the Luciferian agenda that is utilized by the Dark Side.
39. Those whom Paul addresses are "not ignorant" of the tactics employed by the enemy and it is imperative that they possess a clear understanding of them for application in their daily lives.
40. Lucifer has a strategy for world conquest completely worked out in his system of human good and evil.
41. Satan is able to promote his plan through the demon possession and demon influence among unbelievers and the demon influence of reversionistic believers.
