If Abraham failed to grasp the full significance of God's prophetic declaration, Satan did not, and he plotted accordingly. Since God was intent on establishing and blessing the Abrahamic line, then Satan had to attempt to destroy that line.

To countermand Satan's evil design against the promised new race, God affixed a blessing and cursing clause to the Abrahamic Covenant. The clause vouched for sustained divine provision, protection, and preservation of Jews in every generation. God had served notice that the Jew *will* survive human history.

Unlike the first two paragraphs of the Abrahamic Covenant, the anti-Semitism clause applies fully to the unregenerate as well as the regenerate Jew. The race must endure the Tribulation. This is that future time in which all believers of the Church are removed and God is again dealing with Israel as a nation.

Genesis 12:3 is by no means the only statement of divine approval of pro-Semitism and divine condemnation of anti-Semitism.

Thus a correlation exists between the rise and fall of individuals, nations, and empires and their attitude toward the Jew. The clause first presented in Genesis 12:3 serves as a warning not only to Satan and his demonic hoards but to all mankind. God will bless all who bless the Jews and punish all who seek their destruction.³

- 32. It is through Abraham that the line of Messiah is established. Within the Jews race the chart pedigree of Jesus may be observed. The Jew has a special dispensation in history called the Tribulation
- 33. It will be the final opportunity for the Jew to recognize one last opportunity to believe in Christ for salvation. There will be a concerted effort to evangelize the Jews and that message will be spread by 144,000 Jewish evangelists:

After the Rapture the Tribulation commences with three and a half years of power politics in which four major spheres of influence will vie for world domination.

> Paralleling this power struggle unprecedented evangelism will be conducted by 144,000 Jewish evangelists whom God will seal and protect against the anti-Semitic element during the entire Tribulation (Revelation 7:4-10). But in the last three and a half years of the Tribulation anti-Semitism and general alienation toward the Jews will become so intense that the period is called the "great tribulation" (Matthew 24:21-22; Revelation 7:14; 12:17).4

- When Abraham reached spiritual maturity, he demonstrated the power of 34. faith in the working object of doctrine enabling him to place his absolute trust in the grace, authority, and integrity of God when he offered Isaac as a sacrifice on a wooden altar atop Mount Moriah.
- 35. Abraham's working object was primarily the Abrahamic Covenant and the promises attached to it. This is the background to the question posed in James 2:21:

James 2:21 Was not Abraham our father justified by works when he offered up Isaac his son on the altar? (NASB)

- 1. We have taken quite a bit of time and surely enough time to confirm the phrase, "justified by works." It has nothing to do with salvation but rather the application of the Word of God to life and circumstances by a believer.
- Abraham is James's example of a man who "heard the Word" and when put 2. to the test, he "was a *doer* of the Word." Hearing and doing are to entirely different things. It is simple to hear, it complex to concentrate, recall, and actually apply what you know.
- 3. The key to making the transition from hearing to doing is buying into the principle of the law of freedom and absolute confidence in the integrity of God.
- Volition is free to select the status of "hearer only" or "applying what you 4. have heard." The key that binds the two together is "belief." And belief means faith in biblical absolutes as its working object.
- 5. It is much easier to make decisions from facilitated wheel-tracks of human viewpoint developed over the decades than to place absolute trust in a principle recently learned in Bible class.

6. The human viewpoint problem-solving device has been facilitated into a path of least resistance. The biblical principle has not been. The only way to successfully change what you think is to get to the point where you have absolute trust in the integrity of God.

- 7. The integrity of God is the love of God. Love for God is acquired by having absolute confidence in the perfection of God. Integrity refers to the absolute immutability of biblical principles and that the justice of God will bless compliance with them or discipline noncompliance.
- 8. This system is backed by divine omniscience and functions under a policy of grace. God is perfect. We are not. He is therefore patient with the believer who is ignorant of divine viewpoint.
- 9. The system established in Scripture begins with the church, namely the local church in which believers are to assemble for the teaching of divine viewpoint by exegesis, categorical development, the function of the soul in spiritual growth, and resultant blessings associated with compliance.
- 10. The writer of Hebrews indicates how important this "starting point" is in the process of spiritual growth:

Hebrews 10:24 Let us consider how to stimulate one another to love and good deeds,

Hebrews 13:25 not forsaking our own assembling together, as is the habit of some, but encouraging one another; and all the more [regarding the unknown time factor] as you see the day [physical death or the Rapture] dawning near [the incipiency of each].

- 11. The duty of the pastor-teacher is to prepare his sermons under the guidance of the Holy Spirit and then present the information by that same power.
- 12. When the congregation is assembled in church, the communication of Scripture by the pastor-teacher, functions successfully on two levels: (1) the pastor is filled with the Spirit and (2) so are the "hearers."
- 13. This mutual divine dynasphere establishes a spiritual relationship that is empowered by the Holy Spirit. The pastor is enabled to read body language indicating comprehension that produces *epígnōsis* in the *kardía* or incomprehension indicating ignorance in the *noús*.
- 14. If the former, then amplification enhances the subject further, if the latter, repetition is required. The larger the congregation, the dynamics of this pastor-parishioner relationship is enhanced accordingly.

15. We have a television camera nailed to the back wall of this church. Every time I teach a class, there are far more members of the electronic congregation than of the live ones. Television permits outreach that would otherwise be impossible.

- 16. The electronic and live congregations are each benefitted by the spiritual relationship that occurs in the latter.
- 17. I hasten to add that we do not count heads, take rolls, or deploy outreach committees. My job is to teach whoever shows up regardless of the number that occupies the pews.
- 18. All I am saying is that everyone benefits when the local congregation puts top priority on being among the live assembly rather than the electronic. Maintenance of academic discipline is enforced for the local assembly but is absent for the electronic.
- 19. There are legitimate reasons why locals do not attend live Bible classes and it is not my job to demand attendance. That choice is left up to the believer priest, I only observe from afar but without personal knowledge of slack attendance.
- 20. In summary, I am making reference to the *principle* James is *stressing* not the *subject* he is *addressing*. His subject he is addressing is in:

James 1:25 But the one who looks with an earnest desire to absorb in detail the perfect law of freedom, and continues to live in close proximity to it, not having become a forgetful hearer only, but a doer, this man shall acquire unalloyed happiness by the production of divine good. (EXT)

- 21. The principle James stresses is, "not having become a forgetful hearer only, but a doer." This turns out to be a tall order. Based on James's teachings, the problem of converting "hearing" into "doing" is the major cause of a believer's failure to execute the Christian way of life.
- 22. The Christian way of life is based on the teachings of Scripture from an ordained pastor whose approach to teaching follows a strict system of hermeneutics that reveals the veracity of divine thought:

The Doctrine of Biblical Veracity Summarized

1. There are two major doctrines that deal with the process by which God makes Himself known to man: (1) revelation and (2) inspiration. They are often confused with each other.

- (1) <u>Revelation</u>: The divine act of communicating to man what is otherwise unknowable; a disclosure by God Himself regarding things previously unknown and things that cannot be explained.
- (2) <u>Inspiration</u>: God the Holy Spirit so supernaturally directed the human writers of Scripture, that without waving their human intelligence, vocabulary, individuality, literary style, personality, personal feelings, or any other human factor, His complete and coherent message to mankind was recorded with perfect accuracy in the original languages of Scripture, the very words bearing the authority of divine authorship.

Inspiration by the Holy Spirit led the human writers to compile a written record that is classified by conservative theologians as "verbal plenary inspiration."

- 2. Verbal plenary inspiration is a term that combines two concepts:
 - (1) **Verbal Inspiration:** The Bible in its original words, from first to last, is the exact record of the mind and will of God as He intended it to be.
 - (2) **Plenary Inspiration:** The entire text is equally from God but not necessarily equally important or equally indispensable, for example, the Bible quotes human and satanic lies, and erroneous views of false prophets.
- 3- Consequently, verbal plenary inspiration guarantees the accuracy of what is in the Bible, but it does not condone or sponsor errors, evils, or falsehood but merely explains them in detail.
- 4- Dr. Lewis Sperry Chafer gives us a summary statement regarding the differences between revelation and inspiration:

Revelation and inspiration are each in themselves cardinal Bible doctrines and are often confounded. This confusion is perhaps due to the fact that revelation and inspiration must concur, or converge to one point, in securing that infallible divine Oracle which the Bible unhesitatingly asserts itself to be. It is, by its own claims, not only a *revealed* body of truth, but is the *only* revealed body of truth. This claim, of necessity, implies two divine operations, namely, *revelation*, which is the direct divine influence which communicates truth from God to man; and *inspiration*, which is the direct divine influence which secures an accurate transference of truth into language which others may understand.⁵

5. Thus the writers of Scripture received direct revelation from God. Their completed autographs constitute the inspired Word of God. God's plan is revealed to believers through a detailed study of this inspired Word.

- 6. The primary source of revelation to the Church Age believer is the Bible. The secondary source of revelation to the Church Age believer is the interpretation of the Bible by a pastor-teacher who is equipped to analyze the Hebrew and Greek texts by means of a three-fold process:
 - (1) <u>Isagogics</u>: The interpretation of the Bible in the time in which it was written.
 - (2) <u>Categories</u>: The comparing of Scripture with Scripture in order to bring together all that the Bible has to say with regard to a particular subject.
 - (3) <u>Exegesis</u>: The study of the etymology, grammar, and syntax of the original languages of Scripture.
- 7- In its original languages, the Bible is the exact record of the mind and will of God. The inerrancy of the Scripture combined with a pastor-teacher who is filled by the Holy Spirit provides the positive believer with the opportunity to grow in grace.
- 8- The opportunity is made possible by Two Power Options: (1) the filling of the Holy Spirit converts human IQ into spiritual IQ and (2) under the mentorship of the Holy Spirit the believer can then comprehend the supernatural information found in Scripture utilizing the Grace Apparatus for Perception or Operation Z.
- 9. The human authors of Scripture, under the ministry of the Holy Spirit, wrote the books of the Bible under the principle of inspiration.
- 10. The biblical confirmation of inspiration is found in:

2 Timothy 3:16 All Scripture is <u>inspired by God</u> and profitable for teaching for reproof, for correction, for training in righteousness.

- 11. The phrase "inspired by God" is the Greek verbal adjective: θεόπνευστος (theópneustos) "God-breathed."
- 12. This word is a compound made up of the word $\Theta \epsilon \acute{o} \varsigma$ (*Theós*), "God," and the verb $\pi v \acute{\epsilon} \omega$ ($pn \acute{e} \bar{o}$), "breathe." This is obviously an **anthropomorphism:** language of accommodation that ascribes to God human physical characteristics He does not actually possess so man may comprehend His divine policy, character, and function.

13. Breathing involves both inhale and exhale. Inhale illustrates the ministry of the Holy Spirit in inspiration through which he directed the human writers. Exhale illustrates what the human writers wrote down under the Spirit's direction. This is summed up in the statement:

> God the Holy Spirit so supernaturally directed the human writers of Scripture, that without waving their human intelligence, vocabulary, individuality, literary style, personality, personal feelings, or any other human factor, His complete and coherent message to mankind was recorded with perfect accuracy in the original languages of Scripture. the very words bearing the authority of divine authorship.

- 14. The only true confidence in life is based on knowledge of divine thought from which decisions are made and problems are solved. Confidence built on any other system of thought results in a false confidence that cannot stand up under the pressures common to cosmos diabolicus.
- 15. This ongoing, unshakable confidence is built up by spiritual growth but is able to endure trial and testing because of one's core belief that the Bible is the inspired record of God's message to man for life and practice.
- Nevertheless, revelation and inspiration only guarantee the veracity of the 16. Bible.
